

Wendell Farmers Market Vendor Contract

THIS IS A BINDING CONTRACT, READ THE ENTIRE CONTRACT BEFORE SIGNING.

1. The undersigned, hereinafter known as "Vendor" agrees to participate as a vendor for the Wendell Farmers Market and to comply with the provisions of this contract.
2. Vendor agrees to sell at the Wendell Farmers Market during the season which is the first Saturday in April and every Saturday through the last Saturday before Thanksgiving in November. If the Vendor cannot sell on these dates, Vendor agrees to provide notice of the dates on which he or she is unable to sell.
3. Vendor spaces will be assigned on a first come, first serve basis. All fees are due at the time application is submitted. Assigned spaces will not be changed.
4. Vendors are subject to the Operating Guidelines for the Wendell Farmer's Market, available from the Wendell Chamber of Commerce website at [Wendell Chamber of Commerce](#).
5. Vendors agree that they will only sell farm products, value-added farm products and limited approved craft items. All products that the vendor intends to sell at the farmers market will be disclosed on the vendor's application.
6. Vendor may use tents or canopies which must be 12x12 in size. in order to comply . The Chamber does not supply tables, chairs, or tents. Tents must be open sided.
7. Prepared Food: Vendors who wish to sell prepared food items shall be required to obtain a Temporary Food Establishment (TPE) Permit from Wake County environmental services. Questions about TPE should be directed to 919 856-7419. The Wendell Chamber shall NOT be held liable or responsible for any food vendor in obtaining the TPE. No rental fee shall be refunded for failure of the vendor to obtain the necessary TPE.
8. **THE VENDOR SHALL NOT LEAVE THEIR SPACE UNATTENDED AT ANYTIME.** The vendor hereby expressly releases the Wendell Chamber of Commerce against any and all liability for damage, injury, or loss to any person or goods from any cause whatsoever. The Chamber will not provide security and will not be responsible or liable to the vendor for loss at the event.
9. The Chamber reserves the right to make such other changes and further rules and regulations regarding this show as it sole discretion, deems necessary and proper and upon notice to the vendor, all said action shall become part of this lease contract and binding on the parties here.
